## Important information about using continuous monitoring system of comfort / discomfort for newborn infants:

The Mdoloris Medical Systems' continuous comfort / discomfort of newborn infants monitoring system is intended for use in a medical environment and under the direct supervision of a licensed healthcare practitioner or by personnel specifically trained for its use. The continuous monitoring system of comfort/ discomfort for newborn infants is intended for using on patients younger than two years old in a hospital or in a health care facility in order to monitor the parasympathetic tone activity.

The continuous monitoring system of comfort/discomfort for newborn infants can be used to monitor the effects of certain analgesic agents which will improve the comfort.

NIPE is a complex monitoring technology intended to be used as an adjunct to clinical judgment and to clinical experience. The interpretation of the NIPE value must always be submitted to the clinical judgment and with other available clinical signs observed. It is advisable to not rely only on the NIPE index for monitoring the patient comfort. As with all monitored parameters, artifacts and poor signal quality may lead to inappropriate NIPE values. Potential artifacts may be caused by muscle activity or rigidity, patient motion, improper sensor placement or electrical interference.

The NIPE Monitor V1 allows real time transfer data via an RS232 port to an external device. In no case shall transferred data be used for diagnostic purposes. Only the values displayed on the NIPE software interface can lead to a medical interpretation.

The NIPE Monitor V1 needs special precautions regarding environments. The NIPE Monitor V1 has to be installed and put into service in hospitals and away from the RF source magnetic resonance imaging.



### 1.2 Caution

Read this entire manual carefully before using the monitor in a clinical setting.

# Before you boot the monitor, please ensure there is no USB peripheral connected to the monitor (USB stick for example).

The equipment should not be reachable by the patient, directly or indirectly, like placed on a metallic material reachable by the patient.

The patient and the equipment should not be touched simultaneously by the doctor.

Before any use, check for compatible ECG source isolation corresponding to the applicable standards to increase patient isolation safety.

The signal provided by the ECG source must be a Very Low Security Tension output.

Do not put the monitor in an autoclave. Putting the monitor in an autoclave will seriously damage the NIPE Monitor V1.

Using accessories other than those specified may result in increased electromagnetic emissions or decreased electromagnetic immunity of the monitor.

The NIPE Monitor V1 should not be used adjacent or stacked on other equipment. If adjacent or stacked use is necessary, check regularly that the functioning is normal in this configuration.

Only staff of Mdoloris Medical Systems is allowed to perform maintenance operations or repairs. Only the following elements can be replaced or substituted by an untrained staff to the technical maintenance (respecting the manufacturer references):

- « Monitor Link » cable and its different connectors ;
- The power cord ;
- The power supply box.

The recycling of this medical equipment, its components and packaging must be done in accordance with the national laws of the country on electronic wastes and environment.

Be sure that the multi-parametric monitor on which the NIPE Monitor V1 is connected complies with the electromagnetic compatibility requirements of the IIa classification and the double patient isolation IEC 60601-1.

Ask for the list of multi-parameter monitors which are compatible with the NIPE Monitor V1 from your Mdoloris Medical Systems representative. Each of these monitoring systems needs a specific connection adaptor. Please ensure you have transmitted these specifications to your Mdoloris Medical Systems representative.

## 2 Presentation of the NIPE Monitor V1

NIPE (Newborn Infant Parasympathetic Evaluation) is a normalized and continuous measure of the parasympathetic tone ( $p\Sigma$ ) which is a part of the autonomous system (ANS). It uses the punctual and quick increase of  $p\Sigma$  tone induced by each respiratory cycle (spontaneous or artificial) to measure the "relative quantity" of  $p\Sigma$  tone.

These rapid changes in  $p\Sigma$  tone express in the sinus node of the heart by changes in the time intervals between two R waves of the electrocardiogram. The  $p\Sigma$  component is evaluated after filtering, normalization and resampling of the RR series by measuring the area generated by the respiratory patterns. More important is the  $p\Sigma$  tone, bigger is the measured area.

Rapid  $p\Sigma$  tone variations express themselves directly on the sinus node by variations of time interval separating two R waves on the electrocardiogram. The normal next RR series (stemming from a cardiac cycle and not from an extrasystole) establish the RR series. After filtering, normalization and resampling, the  $p\Sigma$  compound of the RR series is obtained by measuring the generated surface by the respiratory cycles.

NIPE measurement cannot be interpreted in the following situations:

- Non-sinus cardiac rhythm;
- cardiac graft;
- drugs affecting the sinus node (Atropine...);
- post-conceptional age lower than 26 weeks.

The NIPE index is expressed on a scale between 0 and 100. It reflects the activity of the parasympathetic nervous system. It gives a reading of the proportion of  $p\Sigma$  tone compared to

the  $\Sigma$  tonus in the autonomous nervous system. The NIPE displayed represents the successions of computed measures: each elementary measure is carried out on 64 seconds, with a 1 second moving window.

The NIPE Monitor V1 is intended to be used by pediatricians and pediatric nurses. For a safety use of the NIPE Monitor V1, the user must know factors that could disturb/skew the NIPE index calculation related to the autonomous nervous system. The NIPE is a decision support tool; the user must take account of the other current clinical parameters before taking a decision or performing a diagnosis.

The diagnostic established with respect to the NIPE index value displayed on the monitor, is the doctor's responsibility.

## **3** Physiological principle of the NIPE measurement

Analysis of Heart Rate Variability (HRV) enables to evaluate the autonomous nervous system's variations, whose parasympathetic and sympathetic components control the cardiac rhythm and its short-term variations. HRV measurement methods are various and validated for many years: the normal or pathologic functioning of the ANS can be appreciated by these methods. Some studies showed that the cardiovascular system's regulatory processes are closely linked to the perception of pain [1, 2]. Analysis of the heart rate variability (HRV) is a well-known and non-invasive method for the measure of the cardiovascular system's regulation by the autonomous nervous system (ANS) [1, 3]. This analysis is based on the principle that the fluctuations of the cardiac rhythm are the reflect of the parasympathetic and sympathetic systems, main components of the ANS. Studies showed that fluctuations of the heart rate over 0.15 Hz are due to parasympathetic system's influence [4, 5]. Phenomena of pain, fear and anxiety, in adults, are accompanied by a decrease of the HRV in high frequencies (>0.15 Hz) that indicates a decrease of the parasympathetic tone during nociceptive stimuli and unpleasant emotions [6, 7, 8]. During a surgical operation, analysis of the HRV is correlated to the balance between nociception and analgesia rate [9]. A significant decrease of the spectral power in high frequencies, in children, has been observed during painful surgical acts. This suggests a decrease of the parasympathetic influence during the nociceptive stimulus [1, 10].

## 4 Installation of the NIPE Monitor V1

#### 4.1 Clamping support

Position the monitor in order to handle easily the power plug. The monitor could be installed on an intravenous stand with the collet fixture. The clamping system can be used on poles with diameter from 0.75 to 1.49 inches. **Please ensure that the pole is compatible.** 

#### 4.2 ECG monitor connexion




Figure 1: connexion cable

Connect the « Monitor Link » to the analogic port of the ECG monitor, then connect the other end of the "Monitor Link" cable to the NIPE Monitor V1 (see figure 1).

To identify the analogic ECG output on your multi-parameter monitor, please consult the operating manual of this multi-parameter monitor.

#### 4.3 Power connector





The power connector is classically plugged into the base. To prevent any accidental disconnection, you can lock the coupling screwing the nut on the base (from left to right, see picture above).

## 5. Start the NIPE Monitoring

Once the monitor is plugged and connected to the multi-parameter monitor, power up the monitor with the switch located on the left side of the NIPE Monitor V1 (figure 3).

The green light situated above the screen indicates that the monitor is starting up.





The monitor will start by showing successively Mdoloris Medical Systems' animations during the start-up phase. Then, the main menu screen will be displayed (figure 4).

From the main menu, you can have access to the following functions:

#### 5.1 Set up language

The user can change the language. Select the button [Язык] situated on the top right hand corner of the main menu (figure 4). The different languages are displayed in a drop down list (figure 5). Choose the language wanted and press [X] to quit and set up the new language.



#### 5.2 Demo mode

The selection of **[Демо]** on the top left hand corner of the main menu shows you a video of the NIPE functioning.

#### 5.3 Start a new recording

The selection of **[Начать новую запись]** launches a new recording. Then the monitor displays the monitoring starting by an initialization step (figure 6). This initialization step takes a minimum of 80 seconds. No data can be interpreted before this initialization time.





When the initialization is done, the initialization of the index starts automatically and the monitoring display appears (figure 7).



#### 5.4 Resume the previous recording

The selection of [Продолжить предыдущую запись] enables to resume the former recording.

**To note:** The NIPE Monitoring can be used with a conscious patient as well as with an unconscious one, whenever the clinician needs it.

#### 6 NIPE display

#### 6.1 ECG capture




Figure 8 - ECG

The lower sub-window displays the ECG acquired by the monitor (figure 8). This ECG is filtered from all environmental artefacts.

#### Case n°1: No signal is displayed:

- Check the connection of the cable between the monitor and the multi-parameter monitor.
- Try at least one time to disconnect and plug again the connection between both monitors to get back a correct ECG signal.

#### Case n°2 – Medium quality signal:

When the quality signal is medium, it is to warn the user that the signal quality may become bad soon.

Case  $n^{\circ}3$  – Poor signal quality: The indications provided by the monitor can't be taken in account if the signal quality reported by the monitor is bad (red colored indicator).

In that case, the NIPE index is not displayed anymore, the curve is not dawned anymore and a message "poor signal quality" appears in the middle of the screen to warn the user.

- Select the button "Автоматический уровень" in the bottom right hand corner of the screen to recalibrate automatically the acquisition of the ECG signal.
- If the signal quality is still medium or poor, choose another ECG lead (on the multi parameters monitor). Finally, check the good position of the electrodes and their adhesion on the skin. Stick them again or change them if it is necessary.

#### 6.2 NIPE index

A continuous indicator is displayed reflecting the patient parasympathetic tone (each elementary measure has been realized on 64 seconds with 1 second of sliding window). A calculation is realized every second then averaged within a "short" period and a "long" period. The monitor displays in blue the NIPE averaged over 20 minutes (long period) and, in red, the instantaneous NIPE when it falls suddenly (significant of the answer to a painful or stressful stimulus). See figure 9.





#### 6.3 Display option of the instantaneous NIPE

The selection of the button [Мгновенный уровень NIPE] will allow you to follow the instantaneous NIPE on the screen. A window will open itself to display the instantaneous NIPE's curve (figure 10).






By selecting the button **[X]** in the bottom left hand corner of the window will close the display of the instantaneous NIPE. The signal acquisition keeps running despite the navigation through the instantaneous NIPE window.



#### 6.4 NIPE browsing

The selection of the button [**Тенденция NIPE**] during the monitoring will display a navigation window (figure 11) which is used to move forwards and backwards the NIPE curve through time and to view the different events which were possibly inserted.

By selecting the button **[X]** the window of the NIPE browsing will close itself. The signal acquisition keeps running despite navigation through the NIPE browsing window.

#### 6.5 Day / Night Mode

It is possible to adjust screen brightness thanks to the Day/Night mode on the main screen.

To set the monitor on "Day" mode, touch the icon




Figure 12 – Day / Night Mode

To set the monitor on "Night" mode, touch the icon  $\checkmark$  (figure 12).

#### 6.6 Standby screen




Figure 13 – Standby screen

From 10 minutes of inactivity, the screen automatically switches to a standby screen (figure 13), except if one of these windows is opened: instantaneous NIPE, NIPE Navigation, Threshold, Events. To go back to the main screen, just touch the screen.

## 7 NIPE Monitor V1 settings

#### 7.1 Threshold setting

It is possible to add a threshold by pressing the button [Предел]. A new window will be displayed (figure 14). Touch the small square next [Установить предел] in order to put a check mark in it and a blank rectangle will appear. Then click in the blank rectangle to activate it (figure 15).





The events saved by default in the monitor are:

- УХОД
- EDIN > 5
- EDIN < 5
- COH
- ПРОБУЖДЕНИЕ

By selecting one of these buttons, the chosen event will be inserted on the NIPE Monitoring display, and also on the *NIPE browsing* display and on the *instantaneous NIPE* display.

The insertion of one of these events will be automatically saved in the "Index" type file, which can be retrieved with a USB key (see chapter 8.3). You have also the possibility to edit your own desired events list (see in that case the chapter 8.4).

If you wish to delete an event inserted on the curve, select this event in the white square and select the button [Удалить]. Then click on the button [X] to get back to the monitoring display.

#### 7.3 Screenshot

When the user selects the button [**Копия** экрана], all the information displayed is saved in the monitor's memory as picture format. Each time the user decides to get a screenshot, one picture will be saved in the monitor's memory.

A message will appear to confirm the success of the screenshot (figure 19). Select the button **[OK]** to remove this confirmation from the display.

To get these pictures, you have to stop the monitoring. To do this, select [Прекращение мониторинга] in the bottom right hand corner of the display. Then plug a USB key in the USB port called "Data Export" on one of side of the monitor.

In the new display (the main menu), choose [Управление записями] then [Записать на USB - ключ]. The pictures will be saved in a folder created automatically on the USB key. The name of the folder follows this rule: Hour-Minute-Month-Day-Year.

## 8 End of the NIPE Monitoring

#### 8.1 Quit the current recording

The selection of the button [Прекращение мониторинга] situated in the bottom right hand corner of the display during the monitoring enables to end the session and to get access to the main menu.

A request for confirmation is proposed before to quit the monitoring (figure 20):

#### 8.2 Maintenance

The selection of the button [**Tex обслуживание**] in the main menu will open a window with an input field (see figure 21). This access is protected by a code that will be forwarded on request by Mdoloris Medical Systems.

#### 8.3 Records management

#### 8.3.1 Export data recordings

The selection of the button [Записать на USB - ключ] will send all data saved in the monitor memory into a USB key. To export the data, you need to connect a USB key in USB port called "*Data Export*" situated on the right side of the monitor. If the monitor doesn't detect any USB key (USB key doesn't plugged or bad connection), a message will appear to inform the user (figure 22). When the USB key is well connected, press on [OK] to start the data export.






#### Note:

Data are automatically saved as text files for an easy secondary reprocessing (with Windows Excel for example). The files will be exported in a folder created on the USB key (like for the screenshots, chapter 7.3). The title of each file indicates the date and hour when the monitoring started. Each file name will follow this rule: Hour – Minute – Month – Day - Year.

The NIPE Monitor V1 allows real time transfer data via an RS232 port to an external device.

<u>WARNING</u>: Moloris recommend the use of an insulation device on the link «RS232 output » between the NIPE Monitor V1 and the device to which it is connected, to respect the electrical insulation and the operator's protection means.

This device that we can denominate « serial isolator » or « RS232 isolator », should respect 60601-1-1 and 60601-1-2 standards.

The company Demetec GmBH markets a device referenced « Medical RS232 Isolation, type Rsl V1.2 » that meet these standards.

#### 8.3.2 Deletion of data recorded

The selection of the button [Стереть записи] will lead the deletion of all data previously saved in the memory. A request for confirmation is proposed (figure 24).

#### 8.4 Events update

As explained previously (see chapter 7.2), events corresponding to different clinical moments are predefined in the system. The events inserted during a monitoring can be envisioned on different displays: *NIPE Monitoring* display (chapter 6.2), *instantaneous NIPE* display (chapter 6.3) and *NIPE browsing* display (chapter 6.4).

The user can customize the list of events:

To access and update the events list, select [Обновить события]. The events update menu will appear (figure 27):

To add new event in the list, you have to use the virtual keyboard on the touch screen and then click on [  $\checkmark$  Подтвердить]. Word size is limited to 18 characters.

The new event will be added at the end of the drop-down list displayed on the right. If there are more than 6 events, you have to use the scrollbar on the right to see all the events of the list.

To delete an event, you have to select it in the list by touching the word on the screen and then select the button [**Худалить**].

To validate any change done (add or deletion of one or more events) you have to confirm by selecting the button [Применить] then [X] to close the events update menu.

#### 8.5 Date and time settings

To set the clock or the date, you have to select [Прекращение мониторинга] to reach the main menu (figure 28). Then, select [Установка даты и времени].



#### 8.7 Shut down

The selection of the button [**О** Выключить] ends the session and will shut down the monitor.

**NOTE:** It is possible to shut down the monitor directly with the switch located on the left side of the monitor (the same that for booting) only if the context doesn't enable you to reach the main menu. This is however not recommended because it could affect the monitor's proper functioning.

## **10** Monitor disposal

**WARNING:** To avoid any kind of contamination or infection on persons, on environment or on equipment, be sure you have properly disinfected and decontaminated the NIPE Monitor V1 before you dispose of your system. You should respect local regulations regarding electric and electronic items.

You can dismantle the monitor and the acquisition card:

- No metal element is molded in the thickness of the monitor's housing
- The inner surfaces of the housing are covered with a protection against electromagnetic interference
- The screen has a touch proof stratified layer
- You can recycle the paper print operating manual
- All electronic items are under the RoHS normalized rules



If you have to dispose of old electrical equipment, make sure it is recycled safely. The "crossed out wheelie bin" symbol found on many electrical items means that they should not be put with normal household rubbish.

## **11 Environnement**

#### **11.1 Shipping and Storage Environnement**

The NIPE Monitor V1 and its accessories can be stored or shipped within the following environmental limits. Note that these limits apply to non-operational storage and shipping situations:

Temperature:-20 °C to +60°CHumidity:15 to 95% (non-condensing)Pressure:480 hPa à 1066 hPa

Protect the monitor from sudden temperature changes that can lead a condensation within the instrument. To minimize the risk of condensation, avoid moving the system between heated buildings and outside storage. Once moved inside, let the monitor in the unopened shipping container to reach the room ambient temperature before unpacking and placing into service. Before operating the system, wipe down all visible condensation and allow the system to reach equilibrium at room temperature.

## **11.2 Operating Environnement**

The NIPE Monitor V1 is not designed for use in areas containing flammable gases or vapors.

**WARNING**: *Explosion hazard: do not use the NIPE Monitor V1 in a flammable atmosphere or where concentrations of flammable anesthetics may occur.* 

The monitor is designed to operate safely in a temperature from  $5^{\circ}$ C to  $35^{\circ}$ C to an altitude of 2000 meters. The conditions that exceed these limits may modify its reliability.

The monitor is designed to operate in a humidity range from 15% to 95% (non-condensing).

The monitor works correctly in conditions of sea level and below, and is not affected by extremes or by altitude modifications to 2000 meters and a pressure from 480hPa to 1066hPa.

### **11.3 Power Requirements and System Grounding**

The NIPE Monitor V1 requires a power source of 100 to 240 VAC, 50-60Hz.

To protect operating personnel and patients, the monitor must be properly grounded. Accordingly, the monitor is equipped with a hospital grade power supply cord. The power cord grounds the system to the power line ground when plugged into an appropriate threewire socket.

**CAUTION:** FOR PROPER GROUNDING, THE POWER SOCKET MUST BE A THREE-WIRE GROUNDED OUTLET. A HOSPITAL GRADE OUTLET IS REQUIRED. NEVER ADAPT THE THREE-PRONG PLUG FROM THE MONITOR TO FIT A TWO-SLOT OUTLET. IF THE OUTLET HAS ONLY TWO SLOTS, MAKE SURE THAT IT IS REPLACED *WITH A THREE-SLOT GROUNDED OUTLET BEFORE ATTEMPTING TO OPERATE THE MONITOR.* 

# 12 Cleaning and disinfection

## 12.1 Cleaning

## WARNING:

UNIVERSAL PRECAUTIONS SHALL BE OBSERVED TO PREVENT CONTACT WITH BLOOD OR OTHER POTENTIALLY INFECTIOUS MATERIALS. PUT CONTAMINATED MATERIALS IN REGULATED WASTE CONTAINER.

Cleaning the monitor:

Clean any spillage of blood or solutions on the monitor. Dried blood is very difficult to remove. Use lint-free absorbent towels to clean spillage. Dampen the towel with detergent and lukewarm water to aid in cleaning. After cleaning, wipe the connector ends with alcohol and allow it to dry completely. Residual moisture inside the connector may affect the monitoring performance.

Cleaning the screen:

Clean the monitor display screen with a mild solution of detergent and warm water or a commercial display screen cleaner, available through personal computer dealers. To avoid scratching the screen, never use abrasive cleaners.

Disinfecting the monitor:

Use lint-free absorbent towels dampened with isopropyl alcohol, with a 10% bleach solution, or a commercial disinfectant.

After cleaning, dry all areas except the monitor display screen with a lint-free absorbent paper towel. Wipe the connector ends with alcohol and allow it to dry completely.

# **WARNING**: WHENEVER AN EVENT SUCH AS SPILLAGE OF BLOOD OR SOLUTIONS OCCURS, RE-TEST LEAKAGE CURRENT BEFORE FURTHER USE.

DO NOT MIX DISINFECTING SOLUTIONS AS HAZARDOUS GASES MAY RESULT.

<u>Cautions</u>: Do not autoclave the acquisition device or monitor. Autoclaving will seriously damage both components.

Avoid liquid ingress with the connection cables. Contact of fluids with the connections cables can interfere with the acquisition performance.

## 12.2 Leakage Current

The NIPE Monitor V1 is designed so that no periodic maintenance is required. However, leakage current should be systematically checked, after spillage of blood or solutions, or after a major surge in the house electrical system or at least once a year.

Preventive maintenance is recommended once a year: cable check, integrity of labels, system check and leakage courant check according to the 62353 standard (for more details, refer to the technical manual available from Mdoloris). However leakage current must be checked systematically after every blood or liquid spill, or immediately after a major surge in the electrical system.

Only Mdoloris Medical Systems qualified technicians and engineers or trained staff are authorized to perform repairs and/or maintenance operations.

Only staff trained by Mdoloris Medical Systems can safely perform maintenance operations (such as software updating or system recovery). However, the following elements may be replaced or substituted by personnel untrained in technical maintenance (following the manufacturer's instructions):

- End User Cable;
- Power cord;
- Power unit.

The equipment returns to the previous operating mode within 10 seconds without loss of any stored data. Measurement accuracy may be temporarily decreased while performing electrosurgery or defibrillation. This does not affect patient or equipment safety. In attendance of electromagnetic disturbances the performances listed below can be lost or degraded:

#### 13.2 Warranty

Mdoloris Medical Systems warrants to the initial Purchaser that the NIPE Monitor V1 ("Warranted Product") will be free from defects in workmanship or materials, when given normal, proper, and intended usage for a period of one year ("Warranty Period") from the date of its initial shipment to Purchaser. Excluded from this warranty are items such as cables and accessories.
